## I. CITY MANAGER'S AGENDA

 Transmitting Communication from Louis A. DePasquale, City Manager, relative to the appropriation of the Massachusetts Formula Grant in the amount of \$173,998.00 funded by the Massachusetts Executive Office of Elder Affairs to the Grant Fund Department of Human Service Programs Salary and Wages account (\$109,283.00), Other Ordinary Maintenance account (\$57,915.00), and to the Travel and Training account (\$6,800.00) which will be used for the Council on Aging Division to provide transportation for Cambridge seniors to medical appointments and weekly grocery shopping trips and will also support an activities assistant, an office aid, a meals assistant and several wellness/exercise instructors and group facilitators who provide services at the Citywide Senior Center. *CMA 2020 #35*

DePasquale, City Manager, relative to Awaiting Report Item Number 19-143, regarding a report on a pilot program with the Cambridge Housing Authority of assigning security officers with CHA premises in and near Central Square and The Port. *CMA 2020 #41* 

This report was submitted in response to a policy order submitted by Councillor Simmons, Councillor McGovern, and myself last October. At the Cambridge Housing Authority (CHA)-owned Manning Apartments in Central Square, safety concerns resulted in elderly and disabled residents taking turns serving as security guards for the building. These residents should not have to sacrifice their peace of mind, or risk their safety acting as security officers, so our policy order asked the CHA and Cambridge Police Department (CPD) to determine a suitable course of action to institute a security presence at these buildings. This communication reports that the CHA has hired a private security guard for the building overnight, and that the CPD will take additional steps, such as adding the CHA buildings to officer patrol routes, to increase safety in the surrounding areas.

This report is a response to a policy order Councillor Toomey filed requesting information on the maintenance and cleaning of trash bins in Cambridge. Open top bins require trash pick up twice a day, and are only cleaned twice a year, and as requested; due to their open tops, these bins are also highly susceptible to rodents. Big bellies, on the other hand, compact trash to a fifth of the space it would otherwise take up, and are completely enclosed, preventing rodents' access. Moving forward, the City should prioritize replacing open tops with big bellies, and the public, especially local businesses, should be educated on how to request trash receptacle cleanings.

#### 1. 100% Affordable Housing Overlay Zoning Petition 2020

# Councillor McGovern, Councillor Simmons, Councillor Sobrinho-Wheeler, Councillor Toomey *POR 2020 #41*

This order is a refiling of the Affordable Housing Overlay Zoning Petition that was brought before the City Council last term. After months of committee meetings, countless hours of public comment, and considerable stakeholder input, the Affordable Housing Overlay was placed on the table before it expired last September. The Affordable Housing Overlay would allow affordable housing developers to build more densely than market-rate developers, and by streamlining the zoning approval process for affordable housing developers, the Affordable Housing Overlay would help affordable housing developers compete with market-rate developers, who often have more resources, and can pay more for land and materials. 2. That the City Manager is requested to confer with the Department of Public Works and other relevant City Departments to determine the feasibility of limiting the number of Saturdays and holidays any one developer can be permitted for any one construction project.

## Vice Mayor Mallon

## POR 2020 #35

I sponsored this policy order asking the City Manager to look into limiting the number of Saturdays and holidays any one developer can be permitted for any one construction project. Currently, construction on Saturdays and holidays is not limited beyond normal construction hours regulated by the City Noise Ordinance. While new construction, especially new residential units, should be made available for use as soon as reasonably available, it cannot be at the expense of the health of residents in the surrounding areas. As many residents are more likely to be at home on Saturdays and holidays, they, as a result, often have to endure high levels of noise all day that deeply impact their ability to relax and enjoy their homes. By limiting the number of Saturdays and holidays any one developer can be permitted for any one construction project, developers can continue to make progress on their projects, and the health and well-being of nearby residents won't be compromised.

3. That the City Manager is requested to confer with the Director of Cambridge Public Libraries to determine the feasibility of eliminating late fines.

Mayor Siddiqui, Vice Mayor Mallon *POR 2020 #36* 

This order sponsored by Mayor Siddiqui, which I co-sponsored, asks the City Manager to look into eliminating late fines in Cambridge Public Libraries. Currently, children's and young adult items do not incur fees, but Cambridge-owned adult materials incur a ten cent fine for each day it is not returned past

its due date, which Commonwealth Catalog and Interlibrary loan items incur a \$2 late fee each day. For so many low-income residents, late fees serve as a substantial barrier to the library, as they may not be able to pay a fine that their more affluent counterparts can. Removing library fines would enhance equity and accessibility, while not posing any significant financial burden for the City, as late fees raise a minuscule portion of the Library's budget, and are associated with additional administrative costs. If late fines were eliminated, Cambridge would join a growing number of municipalities across the country enjoying increased patronage, increased material return rates, and increased access to low-income residents. This order was amended to update library fine statistics included in the text.

## This order was adopted as amended.

4. That the City Manager be and hereby is requested to confer with all relevant City departments and agencies to implement an appropriate shut down time and lighting to add to the plan at Glacken Field Councillor McGovern, Councillor Toomey, Councillor Nolan, Vice Mayor Mallon *POR 2020 #37* 

This policy order requests that lighting be added to Glacken Field. With the Tobin Montessori/Vassal Lane Upper Schools reconstruction, the West Cambridge Little League is being relocated to Glacken Field. With Glacken Field only offering two baseball fields, compared to Tobin's three baseball fields, the West Cambridge Little League will have to extend its practices and games later into the day, when it is dark out. To prevent any potential accidents or injuries that could occur from playing in the dark, this order requests lighting be added to Glacken Field. While there were concerns about the effect the lights could have on nearby wildlife, we are certain that the City would work to ensure there is a minimal impact on nearby wildlife and neighbors.

5. That the Department of Conservation and Recreation reconsider a road diet and protected bike lane for Gerry's Landing Road.

# Councillor Sobrinho-Wheeler, Councillor McGovern, Councillor Zondervan, Councillor Nolan *POR 2020 #38*

This order asks the Department of Conservation and Recreation (DCR) to reconsider its decision to delay the road diet and protected bike lanes along Gerrys Landing Road. The road diet and protected bike lanes were plans included in the Department's 2018 Mount Auburn Street Corridor Study. However, it was announced earlier this month that the Department would be delaying these two plans, and instead keep the current, dangerous traffic patterns until further notice. 29 crashes have occurred at the intersection in question since 2017, and the public outcry of opposition to the delay has highlighted just how necessary this road diet and these protected bike lanes are. Accordingly, the City Council must do everything in its power to encourage the Department of Conservation and Recreation to reconsider its decision.

This order was adopted.

6. That the City Manager is hereby requested to confer with relevant City departments and the MBTA on the feasibility of implementing additional dedicated bus lanes, as well as fully separate protected bicycle lanes.

# Councillor Sobrinho-Wheeler, Vice Mayor Mallon, Councillor Zondervan, Mayor Siddiqui *POR 2020 #39*

This order, which I sponsored alongside Councillors Sobrinho-Wheeler and Zondervan, and Mayor Siddiqui, asks for more dedicated bus lanes to be added in areas with high bus ridership, particularly along Massachusetts Avenue. Our buses have had continual issues with delays, and creating dedicated bus lanes would help them keep on schedule by removing them from high-density traffic, which could, in turn, encourage more people to get out of their cars, and into public transportation. Staying on schedule is also a matter of transit equity, as a middle-income or high-income resident could opt to take a taxi if there were substantial bus delays, but low-income riders cannot, and rely on the bus.

This order was adopted.

7. That the City Manager is requested to produce a Request For Proposal for the municipal broadband feasibility study that was called for by the City's Broadband Task Force in August 2016. Councillor Nolan, Councillor Simmons, Councillor Sobrinho-Wheeler, Councillor McGovern *POR 2020 #40* 

This policy order asks the City Manager to conduct a municipal broadband feasibility study. In response to immense public support for the possibility of implementing municipal broadband, the City Manager appointed a Broadband Task Force in 2014, which worked for over two years to evaluate the City's options. The Task Force recommended that a feasibility study be completed to determine the potential cost, but a study has still not been conducted to this day. In our ever-changing world, the internet is a crucial source that far too many low-income residents do not have access too, as the lack of broadband competition in Cambridge has continually driven up prices. Our City is one that prides itself on equity, accessibility, and innovation, so it is crucial that the City seriously considers municipal broadband as an option, starting with a feasibility study. This order was amended to add Councillor Zondervan as a co-sponsor.
