POR 2020 #50

The 2020 Cycling Safety Ordinance, which is sponsored by Councillor Sobrinho-Wheeler, Councillor McGovern, Mayor Siddiqui and myself, creates a timeline during which the City Manager must build dedicated bike lanes on certain key streets. At our last City Council meeting, Councillor Sobrinho-Wheeler exercised his charter-right to ensure adequate public discussion on this ordinance could be given, as our City Council meetings have moved to an online platform as a result of Coronavirus. As the pandemic continues, Councillor Sobrinho-Wheeler asked to table the ordinance until a later date, as meetings are still being conducted virtually. This ordinance was amended to add Councillors Carlone and Nolan as co-sponsors.

This ordinance was tabled.

This order was adopted.

 That the Cambridge City Council requests that brokers, landlords, and real estate agents not to show housing units with current occupants during the COVID-19 pandemic Councillor Sobrinho-Wheeler, Councillor Simmons POR 2020 #60

This policy order requests that brokers, landlords, and real estate agents do not show housing units with current occupants to prospective tenants until the COVID-19 pandemic is over. As many residents continue to responsibly self-isolate, it is crucial that tenants, especially those with compromised immune systems, are protected from possible transmission. This order was amended to ask the City Manager to enforce this policy of prohibiting landlords from showing occupied housing units to prospective tenants in person.

This order was adopted as amended.

3. That the City Manager is requested to explore the feasibility of using vacant properties and hotels as emergency shelters during the COVID-19 pandemic.

Councillor Sobrinho-Wheeler, Councillor Zondervan POR 2020 #61

This order asks the City Manager to explore the possibility of using vacant properties and hotels as emergency homeless shelters. Transmission among our homeless residents is a high concern, considering homeless shelters may not always be equipped to practice proper social distancing, and as many homeless residents are elderly or have pre-existing health conditions. That's why allowing them to self-isolate in vacant rooms would help flatten the curve of infection, and keep them safe. Councillor McGovern has been working with stakeholders for the past few weeks to explore this idea, and I am thankful for the dedication the City Council has shown towards our homeless residents. In addition, the City is partnering with local restaurants across Central and Harvard Squares to provide meals to homeless residents. This fantastic idea will ensure we are meeting the needs of our most vulnerable residents, while supporting small businesses during these challenging times. 4. That the City Manager is requested to present emergency appropriations to the City Council in order to provide appropriate financial relief to businesses and organizations in the city, especially those which are not receiving sufficient state or federal assistance.

This policy order asks the City Manager to work with Neighborhood Business Associations and the Community Development Department to explore more ways the City can support local businesses during the COVID-19 pandemic. It is a challenging time for our small businesses, as all non-essential businesses have been ordered to close their physical stores, leading to lost revenue, and potentially lost jobs. As the Chair of the Economic Development and University Relations Committee, I was proud to organize City efforts with the Cambridge Community Foundation and New England Development to create the Cambridge Artist Relief Fund. By providing financial assistance to artists and arts organizations over the next several months, the Cambridge Artist Relief Fund seeks to alleviate the impacts of this lost income, and help our Arts community get back on its feet. This policy order, sponsored by Mayor Siddiqui, Councillor Zondervan, Councillor McGovern, and myself, asks the City Manager to execute a "Stay at Home" order for Cambridge. It also asks him to ensure proper social distancing measures are being practiced in essential businesses that remain open,

such as grocery stores. We are at a critical tipping point, as our medical facilities are becoming overwhelmed, creating the possibility for additional preventable deaths. That's why it's so crucial that everyone does their part to flatten the curve of transmission by staying at home when possible, and practicing responsible safety measures when in public. This order complements the "Stay at Home" Advisory Governor Charlie Baker issued for two weeks on Monday, March 23.
