## I. MINUTES APPROVAL

## II. CITY MANAGER'S AGENDA

---

1. A communication transmitted from Louis A. DePasquale, City Manager, relative to an update on COVID-19.

***CMA 2020 #117***

City staff gave a COVID-19 update.

**Traffic, Parking, and Transportation Update:** [The pilot of closing Memorial Drive](#) to vehicular traffic and opening up space for pedestrians and cyclists was a resounding success, so the Traffic, Parking and Transportation Department is working with the Massachusetts Department of Conservation and Recreation to expand closures for Sundays and Saturdays. Although nothing has been officially decided yet, we can expect Memorial Drive to close on Saturdays soon, and potentially expand closures to every day in the future. Staff from the Traffic, Parking, and Transportation Department also shared that the start date for [the Shared Streets Pilot](#) may be pushed back from the originally anticipated start date of June 15th. The City is currently in the process of conducting community outreach to the neighborhood, and making tweaks on their feedback. Opening up additional street space for pedestrians and cyclists so they can physically distance, and creating a network of safe streets is a key way we can ensure our residents can safely travel throughout the City. This will become even more important as Cambridge continues to reopen and as more residents will begin physically reporting to work, so I am hopeful we can move forward with the Shared Streets Pilot as soon as possible.

Additionally, parking regulations, including parking meter payments, will be in effect starting June 15th. The Traffic, Parking, and Transportation Department has also begun taking online appointments, and taking payments in person.

**City Reopening Update:** City buildings are continuing to reopen to staff, and employees reporting to the 51 Inman Street location and the Water Department will begin to return on June 15th. The City has been working with employees to answer questions on returning to work, and to create an internal feedback system. All City employees are also eligible for free COVID-19 testing at the [Cambridge Health Alliance testing site in East Cambridge](#).

[The Recycling Center will also be opening](#) on June 13th. The City Clerk's Office and the Treasury will begin accepting in-person appointments next week as well. As Cambridge has a dense urban environment, the City has been moving slowly on reopening certain high-contact areas. Tennis courts and dog parks are expected to reopen on June 15th, and though [playgrounds will remain closed](#) for now, City leadership is hoping to open them the week of June 22nd. The Main Cambridge Public Library will also begin offering [contactless holds pickup](#) on June 16th. Creating a contactless system to give residents access to physical library materials is something [I've been advocating for](#) these past several weeks, so I am thankful to see this step forward. However, we need to expand this system to other libraries, especially the branch libraries in East Cambridge and North Cambridge. A lot of residents don't live in close proximity to the Main Library, so we have to ensure these library materials are being distributed in an equitable and accessible way.

**Public Health Update:** Cambridge's [COVID-19 case count](#) currently stands at 1,040 positive cases, and 95 devastating fatalities, most coming from residents of nursing homes and long-term care facilities. Although we may feel disheartened at the incredible loss we've experienced from these deaths, the Public Health Department is seeing more residents recover from COVID-19, a hopeful sign. The City's COVID-19 data center has also been updated to include a 'classification' section distinguishing between confirmed COVID-19 cases (those with a positive viral/molecular test) and probable cases (those with a positive antibody/serology test, or those with a clinical COVID-19 diagnosis).

[Free COVID-19 testing has begun in the North Cambridge neighborhood](#); 122 tests have already been administered at this site, and more testing dates to come. Throughout Cambridge, we're seeing a positivity rate of 7.97%, lower than Somerville, Arlington, Boston, and Chelsea, and we also expect this number to further drop, as more and more COVID-19 tests give negative results. The Public Health Department is continuing to provide guidance, explore workforce and remote capabilities, and further examine how we can better support communities of color feeling a disproportionate impact from this public health crisis.

This item was adopted.

6. Transmitting Communication from Louis A. DePasquale, City Manager, relative to the transfer of \$276,600 in the General Fund between School Department statutory accounts as follows: \$276,600 from the School Department Salaries and Wages account to the School Department Travel and Training account (\$276,600) to cover costs associated with all CPS educators participation in six hours of district-wide training focused on social emotional and trauma sensitive supports for educators and students, and on school-based reflection and planning.

***CMA 2020 #122***

This appropriation provides funding for Cambridge Public Schools teachers, administrators, and paraprofessionals to receive training focused on social emotional and trauma sensitive supports for educators and students, and school-based planning. The COVID-19 pandemic has hit our students and our educators especially hard, and the shift to remote learning has been difficult for everyone, so this training will give educators the skillset to better support struggling students, both emotionally and academically. 7. A communication transmitted from Louis A. DePasquale, City Manager, relative to efforts to respond to the restaurant community's need to expand outdoor dining services in response to Governor Baker's announcement that restaurants will be permitted to provide outdoor dining services at the commencement of Phase II of the Commonwealth's Reopening Plan; and to request that the City Council vote to temporarily authorize me or my designee to issue all permits for temporary street obstructions, including Sidewalk Business Use Permits to restaurants that seek to operate outdoor dining on the sidewalk from this date until November 30, 2020 without prior City Council authorization, as explained below.

***CMA 2020 #123***

This item gives the City Manager the authority to issue permits for temporary street obstructions without City Council approval until the end of November. While these permits would usually require City Council approval, removing this barrier will help expedite the process for small businesses, especially restaurants, looking to expand into our public ways. As Cambridge continues to reopen, this will allow restaurants to create or expand outdoor dining, enabling them to accept more customers and increase much-needed revenue. [Applications](#) for this went live last Saturday, and 34 applications have already been received. We have to be creative about the ways we're supporting struggling small businesses, so I also hope we'll be able to deploy a model similar to last year's outdoor kerosene heat lamp pilot to extend the outdoor dining season, and to continue to remove licensing fees and other barriers posed.

The 2020 Cycling Safety Ordinance would create a specific timeline when the City Manager must build dedicated bike lanes on certain key streets. As we will continue to weather the effects of this public health crisis for months to come, and as we anticipate a potential second wave, it is crucial we move forward to expand safe travel options for residents. This item was also amended to allow for more flexibility in the proposed timeline, due to the uncertainty and delays this pandemic has caused. [Click here](#) to read more about these amendments.

1. That the Cambridge City Council schedule a hearing to discuss the possible use of body cameras by the Cambridge Police Department

Municipalities across the country are looking towards reforming their policing practices in the wake of George Floyd's tragic murder, and Cambridge is no exception. Councillor McGovern, Mayor Siddiqui, Councillor Simmons, and I submitted this order to schedule a special City Council meeting on the possibility of having our police officers wear body cameras. This is a conversation that is long overdue, with some pointing out that body cameras do not prevent police violence, while others advocate for their ability to increase transparency and accountability. By holding this hearing at the City Council level, rather than in the Public Safety Committee, we're elevating this issue, and giving each Councillor, not just those on the Public Safety Committee, an opportunity to weigh in.

3. 100% Affordable Housing Overlay Zoning Petition 2020

The Affordable Housing Overlay (AHO) seeks to relax certain zoning restrictions for new affordable housing developers, who typically have a difficult time competing with market-rate developments with more resources. This version includes all of the amendments made when the AHO was originally discussed in the last City Council term. The COVID-19 public health crisis has truly laid bare the striking inequities present in our community, especially surrounding affordable housing. As more residents continue to weather the financial consequences of this pandemic, and as we can only expect the economic recession to worsen in the coming months, we need to act urgently and intentionally on how to promote affordable housing, which is why I asked to be added to this order as a co-sponsor. I look forward to discussing the AHO with my colleagues on the Ordinance Committee as we work towards addressing these disparities and the affordable housing crisis.

Early on in the COVID-19 pandemic, many meals programs frequented by homeless residents closed due to safety concerns, and staffing issues at homeless shelters prevented them from preparing meals on-site. As part of the City's broad efforts to combat food insecurity, [the City began contracting with restaurants to provide meals](#) for homeless residents. Around 2,600 meals are distributed through this program each week, so this is a critical resource for our most vulnerable residents. Audible recently made a generous \$30,000 donation to this meals program, but Councillor McGovern, Councillor Sobrinho-Wheeler, and I submitted this order in the hopes we can continue funding this program through September.

5. That the City Council renews its observance of Loving Day on June 12, 2020 and encourages all Cambridge residents to embrace the diversity of families and recognize the importance of this day

7. That the City Manager be and is hereby requested to report back to the Council on how some, or all, of the \$4.1 million dollar increase in the Police Department budget between FY20 and FY21 may be redirected towards measures that promote public health and safety in other departments

This policy order asks the City Manager to report back to the City Council on how the FY21 budget increase for the Police Department could be redirected. It also asks the City Council to go on record with the intention to only support an FY21 budget that includes significant reallocations of the budget from policing to public health. The budgeting process for the next fiscal year is currently underway, and we, as the City Council, have the authority to make budget cuts, but must have the approval of the City Manager to increase funding. This policy order has gathered a lot of attention, garnering five hours of public comment, and sparking broader community conversations as well. As we address the ways racism permeates our community, and examine ways we can reform policing, it is clear that residents, City Councillors, and City staff alike have passionate, but sometimes conflicting, views on what specific action must be taken. This is a conversation that has only just begun, and it will remain at the forefront of our minds for months to come. These past few weeks, I have been taking the opportunity to listen to those most impacted, and hope to use the invaluable insight I've gained to support reforms that will make
