I. CITY MANAGER'S AGENDA

1. A communication transmitted from Louis A. DePasquale, City Manager, relative to an update on COVID-19.

CMA 2020 #180

City Manager Louis A. DePasquale and Chief Public Health Officer Claude Jacob provided a COVID-19 update.

Emergency Homeless Shelter Update: In August, [the City announced plans](#) to relocate the temporary emergency homeless shelter, currently located at the War Memorial Recreation Center, to the vacant east wing of Spaulding Hospital. City contractors are currently working to renovate the space to better accommodate shelter guests. While the Spaulding Hospital location has an expected activation time of mid-November, supply chain disruptions may push that date farther back.

Testing Update: To date, the City has administered more than 11,000 COVID tests to residents, free of charge. [Click here](#) for more information on getting tested. The Public Health Department has also been working with our local universities, and will create a separate COVID testing dashboard for universities on their [case count webpage](#), as it did for nursing homes and long-term care facilities. Finally, the Public Health Department is working with the Cambridge Public Schools to develop a voluntary testing program, to begin the week of October 5th. One round of testing was already conducted at the King Open School during the last week of August. Learn more about school testing [here](#).

Flu Season Update: As we're rapidly approaching flu season, the Public Health Department will soon launch a flu vaccination campaign. Vaccine clinic schedules will be available later this week, with more details coming in the following days. As many residents may feel apprehensive in a traditional flu clinic setting, we have to get creative, and explore options like drive-thru clinics to encourage as many residents as possible to get vaccinated.

Public Health Update: [Cambridge's COVID case count](#) currently stands at 1,333 cases, 900 of which have recovered. The fatality rate remains at 99 deaths, a devastating loss to our community that has fortunately stabilized across these past several weeks. Overall, Cambridge has a 14-day positivity rate of just .18%, lower than other municipalities with similar population sizes; Springfield stands at .9%, and Quincy at 1%. This is thanks to the conservative, careful approach the City has taken to reopening, and the Public Health Department warns we must remain vigilant.

CITY COUNCIL MEETING OF SEPTEMBER 14, 2020

Since launching in July, the [Cambridge Community Corps](#), a team deployed in local parks, tot lots, and other open spaces to establish community connections and educate on mask use, physical distancing, and proper hand hygiene, has recorded over 600 interactions. This program will continue into the fall, and will help residents navigate the upcoming flu season in these extraordinary times.

The Public Health Department and [COVID Expert Advisory Panel](#) are currently examining the potential roles workplaces and large, outdoor gatherings play in COVID transmission. As the work the Expert Advisory Panel does has significantly informed the City's COVID response, I previously requested that their meeting notes be made available to the public for transparency. These notes are expected to be available online sometime before the City Council's next meeting on Monday, September 21st.

Y2Y is a youth-to-youth shelter that offers homeless young adults a safe living space, case management services, and pathways to stable, permanent housing. Y2Y's operations were threatened when COVID forced the students who typically run the shelter to leave campus. Since then, the City has been working with Harvard to fund shelter operations and bring in professional staff. Councillor McGovern and I have been long-time advocates of supporting this invaluable community resource, so I was pleased to see that Y2Y has been guaranteed funding through the rest of the year. Councillor McGovern also shared during discussion that several Y2Y shelter guests recently received Section 8 Housing Vouchers, and will soon be transitioning into permanent housing.

CMA 2020 #199

This communication offers slightly altered language to the Tenants' Rights and Resources Notification ordinance that Mayor Siddiqui, and Councillors Simmons, Sobrinho-Wheeler, and McGovern sponsored. The new language now requires that landlords provide tenants with a notice of basic housing rights and resources at the start of tenancy, in addition to the start of eviction proceedings. The amendments also exclude short-term rentals from the list of included residences. This ordinance was amended by substitution with the updated language. As we prepare for the inevitable tsunami of evictions that will follow the expiration of Massachusetts' eviction moratorium, it's crucial we do everything we can to promote housing stability and ensure tenants know their rights and the resources available to help them in difficult times.

CHARTER RIGHT EXERCISED BY COUNCILLOR SIMMONS IN COUNCIL JULY 27, 2020

No industry has been hit harder by this pandemic than the Arts and Culture Sector. Arts organizations were the first to close their doors, and will be the last to reopen, and as their ability to offer programming, and to profit from it, largely relies on safe access to physical space, they are placed in a uniquely vulnerable financial position. That's why Mayor Siddiqui and I were proud to advocate for this amendment to the Mayor's Disaster Relief Fund to include these arts organizations, in the hopes of providing immediate relief to the mid-sized cultural institutions that make up the heart and soul of Cambridge's Central Square Cultural District. However, Councillor Simmons exercised her charter-right due to unnamed concerns, delaying the distribution of this desperately needed relief by over a month. With this wait, our already endangered Arts institutions are now barely hanging on, and without this relief, most wouldn't survive to see the next several weeks. Once these sorts of institutions close, they never return. This would send devastating rippling effects through the surrounding, struggling small businesses that rely on Arts event attendees to stop for dinner at their restaurant, have a drink at their bar after the show, or grab a souvenir at their gift shop. This relief could not have come quickly enough, and while I was glad to see this crucial amendment be supported by most of my colleagues on the City Council, this one effort isn't enough. We must remain committed to the Arts organizations that have lifted our spirits and eased our stress during these unprecedented times, and we have to get creative about providing additional financial support to those who have given us so much back. This policy order from Councillors Zondervan and Sobrinho-Wheeler asks the City Manager to explore moving traffic enforcement responsibilities to a trained, unarmed civilian group. I previously exercised my charter-right on this policy order to give the co-sponsors time to determine whether this order would conflict with a Massachusetts state law stating that only police officers can issue traffic citations. After speaking with [the Justice Collaborative](#), Councillor Zondervan determined that this wouldn't violate state law as long as the civilian group doesn't issue citations, but rather serves in a mainly educational role. I look forward to discussing this proposal further in the Public Safety Committee, and continuing to serve as a leader in re-imagining policing so that public safety feels safe to everyone.

By making streets safer, we're also taking a much-needed step in advancing our climate change mitigation goals by encouraging more residents to choose a greener mode of transportation. I was happy to support the Cycling Safety Ordinance and see it pass to a second reading; however, I hope we can work harder to give small businesses a seat at the table and include them in these conversations in a more meaningful way in the future. Major street changes such as these could have a significant impact on the way residents can patronize their stores, and, as a City Council, it is our responsibility to juggle our goals for promoting transit safety with our goals for supporting small businesses.

This effort has been over a year in the making, and is a crucial step in promoting socioeconomic and racial equity throughout the City we love. I am incredibly grateful for the tireless advocacy from some of my colleagues on the City Council, affordable housing developers, and countless residents that have made this effort possible. The City Council voted to pass the AHO to a second reading, and, moving forward, we must continue to invest in fair, affordable housing by further examining restrictive zoning, expanding source of income housing discrimination testing, funding additional staff support in the City Manager's Housing Liason's Office, and so much more. The next, and final, vote to ordain the AHO will be on Monday, October 5th.
